# 2022 Vendor Terms & Conditions

Saturday September 24, 2022

I wish to participate as a vendor at the **2022 Model Car & Slot Car Flea Market** on Saturday, September 24, 2022, at the **Franklin Horner Community Centre**, 432 Horner Avenue, between Browns Line and Kipling Avenue, Toronto (Etobicoke), approximately 1 mile south of the QEW. Take HWY 427 South which turns into Browns Line, continue South on Browns Line (about 1 mile) to Horner Avenue, East on Horner Avenue to 432 Horner Avenue (North side). Parking at rear.

*I understand that my signature at the bottom of the contract form indicates that I have read, understood and accepted the following Terms and Conditions as printed on this page:*

**SECURITY:** The hall will be opened for access on Saturday morning at 8:00 am. To ensure prompt, secure and stress-free setup for our vendors, we have decided not to sell floor rights at this show. Public access will commence at 9:30 am. Vendors will be expected to stay setup till 3:30 pm.

**SALES SPACE:** Tables will be supplied without table coverings for the spaces. Please let us know if you want to bring your own tables or displays when you return your application.

**TABLE ALLOCATION:** The allocation of sales space will be made by date of receipt of your completed contract with full payment. Contracts received after September 10, 2022 will be put on a waiting list.

**ITEMS FOR SALE:** We prefer that vendors focus on the slot & model car/truck/motorcycle hobby. Vendors of new, old or previously built kits, aftermarket enhancements for kits, promotional or pre-built vehicle models, reference material, specialized modeling tools and supplies are specifically welcome. All exhibitors are subject to the approval of the Show Managers and Group 25 Executive. All items offered for sale must be clearly priced. All reproduction items must be clearly marked as such.

**SET-UP TIME:** 8:00 am to 9:30 am on the day of the event. Dealers must be set-up by 9:30 am and must remain set-up until 3:30 pm and must remain set-up until 3:30 pm or the start of the awards ceremony, whichever is earlier. The general public will pay to attend from 9:30 am until 3:30 pm, and expect to see a complete show. Failure to remain set-up for the full show could result in exclusion from future events. The privileges of set-up time are only for those persons vending in the Show. This will be strictly enforced. With the limited time for setup, we would ask that vendors also show some respect to each other and the waiting public in this regard, and not start swapping until fully set up. No independent floor-trading privileges will apply.

All persons on the trading floor must wear authorized ID badges as supplied by the show management.

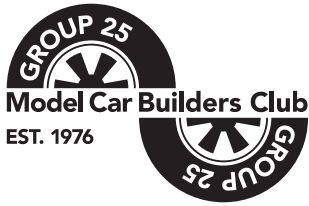
**HELPERS:** Only one vendor and one helper will be permitted per dealer without the express written permission of the Show Managers.
